Current state of EQF implementation

- 38 countries participate in the EQF process
- 30 are working on comprehensive NQFs (6 have introduced partial NQFs)
- 25 frameworks have been formally adopted
- 26 countries have presented their referencing reports
- 23 countries have referenced to the EQF

Validation of non-formal and informal learning

- New task of EQF AG follow the implementation of the Council recommendation on the validation of non-formal and informal learning (20.12.2012)
- Until 2018 each member state should write a report how this recommentation is implemented at national level

Four validation elements for LO

acquired through validation of non-formal and informal learning

- o Identification of an individual's learning outcomes
- Documentation of an individual's learning outcomes
- o Assessment of an individual's learning outcomes
- Certification of the results of the assessment of an individual's learning outcomes

European area of skills and qualifications

- Qualifications frameworks EQF & QH-EHEA
- European skills Europass, Youthpass
- Quality assurance ESG, EQAVET
- Credit points ECTS, ECVET
- Recognition instruments Lisbon convention, NARIC network, directives, RPL, NFIL
- Information centres and web portals Ploteus, Europass, EQF NCP, Eurodesk, Euroguidance, Learning oportunities
- Instruments for promoting common understanding of skills – Skills Panorama, ESCO

Global dimension of the EQF

- EQF is internationally recognised as a reference:
 - Most EU neighbourhood countries develop qualifications frameworks
 - Many new QFs outside Europe use the EQF as source of inspiration
- Pilots on testing possible alignment of the Australian QF, the New Zealand QF and the Hong Kong QF to the EQF
